This Guide provides fees and funding information for prospective graduate students wishing to take up a place at Oxford in the 2009–10 academic year. It tells you how much it will cost to study at Oxford, and gives advice about how to seek funding to help you finance your course.

Graduate study at Oxford is a rewarding experience but is also a significant investment. Because we seek applications from students of the very highest calibre, irrespective of their background or personal circumstances, we aim to ensure that as many outstanding candidates as possible have sufficient funding opportunities to enable them to take up their place.

Currently, 45% of all graduate students at Oxford are fully funded by scholarships/awards, with this figure rising to almost 60% of research students. The Guide gives specific examples of funding opportunities that are available to new graduate students in 2009–10.

This Guide is aimed at full-time students as the majority of graduate courses at Oxford are only provided on a full-time basis. If you would like information about fees and funding for a specific part-time course, please contact us directly.

If you need information about applying to Oxford, its colleges, or the courses that you can study here, please start by referring to the Graduate Studies Prospectus 2009–10 and/or the Graduate Admissions Office. Contact details for this and other useful offices are provided on page 7.

What will it cost to study at Oxford?

There are three types of expense that you must budget for when calculating the cost of your graduate course:

- University fee (also known as tuition fee)
- College fee
- Living costs

Your prospective college will require you to complete a financial guarantee as a condition of your place, so you will need to be able to show how you intend to fund all three of these elements in full for the duration of your course.

Tuition and college fees are fixed for each year, but are subject to variation between one year and the next. Generally speaking, you should budget for an increase in all fees and living costs of approximately 3–5% per year.

Tuition fees

Tuition fees are payable to your college for each year of your course that you are liable to pay fees (please see the separate section on fee liability). The rate you pay depends on the University's assessment of your fee status as 'Home/EU' or 'Overseas' (please see the separate section on fee status). 2009–10 tuition fees have not yet been confirmed and will be published in September 2008. Fee lists will also be available online at www.ox.ac.uk/current_students/fees.html. As a guide, a list of 2008–09 graduate tuition fees is included in Appendix 1 at the end of this booklet, as well as online. Please be aware that other programmes are likely to be added to the list of non-standard fees for 2009–10.

A limited number of programmes may be undertaken on a part-time basis. With the exception of the EMBA, part-time programme fees are normally set at half the applicable full-time fee rate over twice the applicable length of time for full-time students. Special fee rates apply to some programmes offered by the Department for Continuing Education: www.conted.ox.ac.uk

Although fees are incurred on a termly basis, colleges usually require students to pay a full year's fees in advance. For some courses at the Saïd Business School, fees are charged for the whole programme with only very limited refunds possible for years or terms not started. Some courses also require a deposit to be paid prior to the start of the programme.

If you are in any doubt about the fee level applicable for your chosen programme of study please contact the relevant department or faculty office or refer to the University website.

College fees

The college fee is payable to your college. It covers academic facilities and other services provided by your college. The fee, which is payable annually for the period you are liable for fees (see below), does not include accommodation or meal charges and is payable in addition to the University tuition fee. Each college sets its own fee, although fee rates do not vary greatly between individual colleges.

Living costs

The UK has a high cost of living and your expenses will vary depending on your individual needs. It is generally more expensive to live in private rented accommodation than in college accommodation. Your living costs will also be higher if you intend to bring any dependants with you whilst you are resident in Oxford.

Your living costs budget should include, but may not be limited, to:

- Accommodation
- Food
- Clothing
- Other personal requirements
- Books
- Stationery
- Special course equipment
- Travel to and from Oxford
- Research expenses (e.g. fieldwork or travel)
- Inflation and fluctuations in exchange rates
- Medical expenses not covered by the National Health Service
- One-off expenses at the start of your course (e.g. bicycle, computer)
- Any other expenses relevant to your circumstances (e.g. childcare)

Estimates for maintenance costs for academic year 2009–10 are not yet available. For up-to-date information, please see: www.admin.ox.ac.uk/postgraduate/finance/fees.shtml. For guidance purposes, a reasonable estimate for the cost of living for a single student spending 12 months in Oxford and living in college accommodation or in a shared house would be between £10,500 and £13,000 for the 2008–09 academic year:

Accommodation	£4,500 - £5,500
Food	£3,000 - £3,500
Other daily living costs	£3,000 - £4,000

There is very limited financial support available if you encounter financial difficulties after you have started your course, particularly for international students. Any application for this limited emergency support must show evidence of why your financial situation has changed so unexpectedly. You should therefore ensure that you have all your funding in place for the length of your course before you commence study in Oxford.

Fee status

Simply put, all graduate students have to pay tuition fees and this will be at one of two rates: the 'Home/EU' or the 'Overseas' rate. It is important that your fee status is correct, as this is the basis for the University's decision on whether you should pay the Home/EU tuition fee or the Overseas tuition fee. It is not the University's judgement of your nationality.

The definitions adopted by the University to classify students as 'Home/EU' or 'Overseas' for fees purposes are given in Appendix 2.

However, these definitions and, in particular, the phrase 'ordinarily resident' need interpretation; being a UK or EU national does not automatically qualify you for 'Home/EU' fee status.

Fee liability

Fee liability means the length of time that you have to pay tuition and college fees to the University. Your normal period of fee liability will usually be the same as the standard length of your course. The table below gives information for full time courses on the expected completion time and the maximum number of terms that fees are payable for. Both expected completion time and maximum fee liability are different for part time courses. Additionally, if you continue straight from one graduate degree at Oxford to another, this may affect your fee liability. For example, students reading for a DPhil after completing an MPhil or BPhil may have reduced fee liability for the DPhil.

In addition, you will also have to pay the standard college fee to your college for the duration that you are liable for tuition fees. If you need to continue studying beyond these timeframes, your college may charge you a continuation fee:

For new students starting in 2009–10, your fee liability will normally be as follows:

Our advice is to start looking for funding opportunities as soon as you have decided to apply to Oxford, if not before. Explore all avenues open to you, and think creatively about putting together the funding package that is right for you. Before applying, read the eligibility criteria thoroughly and make sure you submit your application before the deadline: these two factors can save you a lot of time and potential heartache.

It is important to note that most funding applications can only be made at the time you apply for your course at Oxford, and small hardship funds are only granted in exceptional circumstances which could not have been foreseen at the time of completing your financial guarantee.

Loans

If you are unable to obtain scholarship or grant funding for your studies at Oxford, another option may be to take out an education loan to meet your costs. Loan funding is dependent on your country of residence, as it is often linked to government or state-run schemes, so you should contact your local education authority or Department of Education for more information about loan schemes available to you.

If government or local authority funding is not an option (particularly for countries which do not fund students to study abroad), you could look into the possibility of private education loans. In general, UK banks are reluctant to lend funds to non-UK residents, so you will need to approach lending institutions in your home country. UK residents should compare bank loans before making an application: although some UK banks offer loans specifically for graduate students to fund their studies, interest rates and other terms and conditions will vary widely.

Wherever possible, apply for lower interest government or subsidised loans first, and only then apply for higher-interest private loans if you require additional funds. Be aware that some loan programmes may have a limit on the amount of funding they can provide. Will this amount be sufficient for the duration of your course?

Over the page, you will find more detailed information on loan programmes that students at Oxford most commonly apply for.

Federal loans for students from the USA

The University of Oxford is eligible to certify loan applications for the Federal Family Education Loan Program (FFELP) for US citizens or residents. Student Funding Services will guide you through your application, from initial enquiry to disbursement of loan funds. We are responsible for 'certifying' all US federal and private loans, which means that we request the specific loan amounts needed from your chosen lender, and confirm the dates that you will be enrolled at Oxford.

This loan programme may not be suitable for students at Saïd Business School. If you are a prospective Saïd Business School student, please see the section opposite on private loans.

There are two loan types available to you under FFELP. This table shows a summary of the loan amounts available for each year of study, with detailed information below.

Stafford subsidised	Stafford unsubsidised	Grad PLUS
maximum \$8,500	maximum \$20,500 (minus Stafford subsidised)	no maximum, although not to exceed cost of fees, living and travel, minus Stafford loan amount

Stafford loans

The Stafford loan is split into two parts. Firstly, a subsidised loan of \$8,500 is available, but only if your 'Expected Family Contribution' (EFC) is not higher than your overall costs. The EFC is an amount determined through means testing, and will be available to you once you have made your initial Free Application For Federal Student Aid (FAFSA) through the US Department of Education. If you qualify for a subsidised Stafford loan, the interest (6.8%) will be paid on your behalf by the US government, as long as you remain in full-time education. The second part of the Stafford loan is unsubsidised, and is a maximum of \$20,500, minus any subsidised Stafford allowance.

Grad PLUS loans

Once you have exhausted your Stafford loan eligibility, you can then apply for a Grad PLUS loan. This loan was introduced in 2006, and is a variation on the Parent PLUS loan available to parents of undergraduate students. However, graduate students apply for the PLUS loan in their own right. There is no maximum amount for a Grad PLUS loan, but it must be no more than the difference between a student's full costs and their Stafford loan amount. In other words, you can apply for a Grad PLUS loan to meet all legitimate fee, living and travel costs beyond \$20,500. Graduate students typically apply for a Grad PLUS loan in the region of \$25-30,000 per year, but this will depend on individual circumstances. The current interest rate for Grad PLUS loans is 8.5%.

You can only apply for federal loans one year at a time, but this will not affect the financial guarantee you must submit to your college. If you intend to use federal loans to fund the duration of your studies, please state this on your financial guarantee form, and sign the form yourself. You do not need to ask your lender or loan guarantor to act as a signatory. Private loans for students from the USA

If you are a US citizen or resident, but are not eligible to receive federal funding, you may be able to apply for a private education loan. Please be aware however that, following the recent downturn in private lending, you may need a friend or relative to co-sign your private loan, particularly if your credit history is below average.

You should only apply for a private education loan once you are sure that you are not eligible to receive federal loans – please contact Student Funding Services, if you are unsure of your eligibility status. It is important to note that many Saïd Business School students are required to take out private education loans to pay for their tuition fees. This is because Saïd Business School require fees to be paid up-front at the beginning of the academic year, and federal loans can only be disbursed in quarterly instalments. The full fee payment requirement cannot be waived for students funding their studies through federal loans, but you may still wish to apply for federal loans to fund your living costs.

Federal and provincial loans for students from Canada

Unlike US federal loans, Canada student loans require much less involvement from the University of Oxford, although Student Funding Services can assist with the completion of enrolment forms and tuition fee confirmations. Please contact us directly (us.loans@admin.ox.ac.uk) if you require this service.

There are two main categories of Canadian government student loan programmes:

- 1. The federal programme**, called the Canada Student Loans Program (for full-time and part-time students).
- 2. Provincial and territorial programmes**. In four provinces, provincial-federal loans programmes are integrated. You apply to only one agency (your province of residence) and your loan management and repayment will be through the National Student Loans Service Centre (www.canlearn.ca/eng/main/help/contact/csl.shtml). The four provinces offering integrated student loans are: Ontario; Saskatchewan; Newfoundland and Labrador; New Brunswick.

All remaining provinces and territories, with the exception of Yukon, offer stand-alone loan programmes. You apply to one agency to receive your student financial assistance, but will receive and manage two separate loans. Loans for students from other countries

If you are a student from a country other than the UK, USA or Canada, you may still be able to apply for loans to fund your studies at Oxford, by applying through the government or a private lender in your home country.

The recent credit crunch has affected the availability of loans for overseas students, so please be aware that it is increasingly difficult to gain funding approval from a lender (unless you are eligible for the US and Canada programmes outlined above). Until recently, overseas students were able to apply for private education loans through the American lender TERI, providing a US citizen was prepared to co-sign their loan. Unfortunately, the International Student Loan Program (ISLP) is no longer available, and at the time of print, Student Funding Services were unaware of any similar, alternative loan programmes open to overseas students.

On the following pages you will find detailed information about specific scholarship opportunities that will be available to graduate students starting a new course in 2009–10. These are divided into four categories:

- **Central:** See p8. Scholarships available at more than one college/department and managed by Student Funding Services. You can apply for most of these scholarships at the same time as you complete the Graduate Application Form to apply to Oxford, but no later than Application Deadline 2.
College: See p12. Scholarships worth over £2,000 (as fees, maintenance or in-kind support) available at the colleges of the University.
- **Departmental:** See p28. Scholarships worth over £2,000 (as fees, maintenance or in-kind support) available at the Departments of the University.
- **External:** See p 46. Major external bodies that provide at least 50% of funding are included. Note that this list is not exhaustive.

There may be other college/departmental awards available in 2009–10 which were not confirmed at the time this Guide was published, as well as awards of less than £2,000, which have not been included in these tables. Check your prospective college/department's website for the latest information.

You should look through the table carefully to see which funds you may be eligible for. Applications to funds may be dependent on you accepting a place at a particular college, studying in a particular subject area or that you are from a particular country or region.

Please note that many scholarships awarded for more than one year will be subject to renewal, and you will need to make satisfactory academic progress in order for your award to be renewed. Some one-year awards may only cover nine months' worth of expenses, for courses that run from October to June. You can also use our online Oxford Funding Search www2.admin.ox.ac.uk/io/iowards/search.php5? to look for scholarships using a range of criteria such as your nationality, course, college or department. You can link straight from the results of the search to the relevant webpage to get full information about available opportunities.

Application Deadlines

For most central scholarships, you will need to apply for admission to Oxford by Application Deadline 2, but deadlines for college and departmental awards will vary. Please consult the relevant website for more information.

Employment

Study at Oxford is very demanding. It is recommended that you consult your supervisor before undertaking regular paid employment. International students should check their UK visa to make sure it contains no limitation on working. However, if you do decide you want to look for a part-time job, these are some possibilities:

- Teaching/supervision opportunities may be available in your department and you should contact them to discuss whether this is a possibility.
- Colleges periodically advertise for Junior Deans, who provide pastoral care to other students and are on-call day and night several times a week. Junior Deans normally receive free college accommodation, free meals and a stipend of around £1,000 per year;
- Ad-hoc work can sometimes be found by advertising your skills locally as a tutor, translator or proofreader;
- www.dailyinfo.co.uk is a good source of part-time and short-term jobs in Oxford, and is updated daily;
- The best local newspaper for employment opportunities is the Oxford Times, which is published each Friday (www.theoxfordtimes.net). Most jobs advertised are full-time.

Be creative – and focussed

If you have recent work experience, it may be worth contacting one of your past/present employers to find out whether they may be able to offer you support. Also consider approaching an employer of the future. Investigate companies/organisations working in your research area, particularly those with CSR (corporate social responsibility) aims and target them. Think creatively and strategically about other bodies you may be able to proactively approach for funding. They might not necessarily advertise scholarships or bursaries, but could you make a convincing case for them to support you?

Consider the following when approaching an employer or other body:

- Your initial approach, especially if the organisation does not appear to provide support for graduate students, needs to be concise, memorable and tailored to the needs/aims of the body you are contacting. Take the time to get a contact name in the organisation. A generic, open letter to the CEO is a waste of everyone's time;
- Enclose a short version of your research proposal. Remember that you may need to make it more user-friendly for non-specialists;
- Be specific: how much funding do you need, could any of this come from in-kind support (equipment/use of research facilities/work experience etc) and what will you use the funds for?
- Think about what you can offer a potential sponsor. Could you undertake some research for them, give them free publicity, give a lecture/presentation, write a report... etc?

Are there any foundations in your local/home community that would be willing to support you?

Students with children

The University has a number of subsidised nursery places, a subsidised play scheme, and a limited amount of funding available. If you are interested in getting a University subsidised nursery place, we strongly recommend that you contact the Childcare Officer (childcare@admin.ox.ac.uk) as soon as you have received an offer of admission because there are long waiting lists for nursery places. UK students can apply to the Access to Learning Fund (ALF) for extra financial help while studying and all matriculated students are also eligible to apply to the University's Childcare Relief Fund. This fund makes one-off awards towards childcare provision costs in emergency circumstances. For both funds the level of award takes into account the financial circumstances of the applicant.

There is also a limited amount of government support available. UK students and some other categories of students may be eligible for Child Tax Credits from the Inland Revenue. To find out more, telephone 0845 300 3900 or visit www.hmrc.gov.uk/taxcredits/

UK PGCE students may be eligible to apply for the Parents' Learning Allowance and the Childcare Grant. In order to qualify for a Childcare Grant, students must be paying for registered childcare. You should visit www.direct.gov.uk/studentfinance/ for further details.

Students with disabilities

If you have a disability that may affect your studies we recommend that you contact your department, the University Disability Office and the colleges you are interested in at the earliest opportunity to discuss specific needs.

Although there are no grants available from the Disability Office for fees and/or subsistence, you may be entitled to either Government funding or University funding to help with study related needs.

UK students may be eligible for a Disabled Students' Allowance (DSA) which provides funding for extra costs arising during study because of disability. The amount awarded is determined by an assessment of need, not income. You should contact your Local Authority or equivalent or visit www.direct.gov.uk/studentfinance/ for further details. Research Councils and other funding bodies offer similar support and you should contact them for more information. Home students can also apply to ALF for disability related costs not covered by their DSA once they have started their course.

The University's Southern Trust Fund supports students who, because of their disability, need specialist equipment or other assistance. Grants can be made to students applying to Oxford, to fund such things as the provision of support and travel costs, but are not normally considered in retrospect.

Classification of students for fees purposes

The University currently applies the following definition of persons entitled to be charged University composition fees at the appropriate 'home' (and EU) rate.

- 1 A person who on the relevant date: (a) is settled in the United Kingdom within the meaning of the Immigration Act 1971, and (b) meets the residence conditions referred to in paragraph 9.
- 2 A person who is a refugee, ordinarily resident in the United Kingdom and Islands, who has not ceased to be so ordinarily resident since he or she was recognised as a refugee, or is the spouse, or child of such a refugee.
3.
 1. A person who:
 1. has been informed in writing by a person acting under the authority of the Secretary of State for the Home Department that, although he or she is considered not to qualify for recognition as a refugee, it is thought right to allow him or her to enter or remain in the United Kingdom
 2. has been granted leave to enter to remain accordingly, and
 3. has been ordinarily resident in the United Kingdom and Islands throughout the period since he or she was granted leave to enter or remain or who is the spouse or child of such a person and who was such at the time of the principal's asylum application to the Home Office.
 2. For the purposes of this paragraph 'child' includes a person adopted in pursuance of adoption proceedings and a stepchild.
4. A person who was admitted to his or her course in pursuance of arrangements with an institution outside the United Kingdom for the exchange of students on a fully reciprocal basis.
5. A person who is a national of a member State of the European Union, or who is the child of such a national, who meets the residence conditions referred to in paragraph 9.
6. A person who is an European Economic Area* (EEA) / Swiss migrant worker who:
 1. may not be required to pay higher fees, or who may not be made ineligible for an award under rules of eligibility, by virtue of Article 7(2) or (3) of Council Regulation (EEC) No. 1612/68 on freedom of movement of workers within the Community, as extended by the EEA Agreement, or, where he or she is a national of the United Kingdom, by virtue of an enforceable Union right to be treated no less favourably than a national of another member State in relation to matters which are the subject of Article 7(2) and (3), and
 2. meets the residence conditions referred to in paragraph 9.
7. A person who is the spouse of an EEA/Swiss migrant worker and who: (a) is installed in the United Kingdom with his or her spouse, and (b) meets the residence conditions referred to in paragraph 9.
8.
 1. A person who is a child of an EEA or Swiss or Turkish migrant worker and who:
 1. may not be required to pay higher fees, or may not be made ineligible for an award under rules of eligibility, by virtue of Article 12 of the above mentioned Council Regulation, or, where his or her migrant worker parent is a national of the United Kingdom, by virtue of an enforceable Union right to be treated no less favourably than the child or a national of another member State in relation to matters which are the subject of Article 12, and
 2. meets the residence condition referred to in paragraph 9.
 2. For the purposes of this paragraph 'parent' includes a guardian, any other person having parental responsibility for a child and any person having care of a child, and 'child' shall be construed accordingly.
9. The residence conditions referred to above are that:
 1. the person has been ordinarily resident throughout the three-year period preceding the relevant date, in the case of a person mentioned in paragraph 1, in the United Kingdom and Islands, or, in the case of a person mentioned in paragraphs 5 to 8, in the European Economic Area or Switzerland or EU Overseas Territories (or in the case of the child of a Turkish worker; in the European Economic Area or EU Overseas Territories or Switzerland or Turkey); and
 2. his or her residence in the United Kingdom and Islands, or in the European Economic Area or Switzerland or EU Overseas Territories (or Turkey), as the case may be, has not during any part of the period referred to in sub-paragraph (a) been wholly or mainly for the purpose of receiving full-time education; and
 3. in the case of a person mentioned in paragraphs 6 to 8, was ordinarily resident in the UK and Islands on the relevant date.
10. A person shall be treated as ordinarily resident in the United Kingdom or the EEA if he would have been so resident at the relevant time but for the fact that he, his spouse, his parent, guardian, any other person having parental responsibility for him, or any person having care of him while he is a child, is or was temporarily employed outside the area in question.
11. A reference in this Appendix to the relevant date is a reference to 1 September, 1 January, or 1 April closest to the beginning of the first term of the person's course.

Any student who does not meet the criteria outlined above is charged University composition fees at the appropriate 'overseas' rate. In determining whether students are liable for University composition fees at 'home' or 'overseas' rates, the University applies the above criteria. It should however be noted that these are liable to be changed from time to time to conform to national legislation.

*The European Economic Area is made up of all the countries in the EU plus Iceland, Liechtenstein and Norway.
